## CERTIFICATION DESCRIPTIONS

### **Direct Support Professional (DSP)**

is a certification issued by the State of Maine that enables you to help people with developmental disabilities live in their own homes and integrate with the community. If you have your DSP certificate you can work in a human service social setting and help adults with developmental disabilities.

### **Mental Health Rehabilitation**

**Technician (MHRT-1)** is a certification issued by the State of Maine that enables you to help people with medication administration, crisis intervention and management or assist people in developing effective coping skills. If you have your MHRT-1 certificate you can work in a human service social setting and help adults with mental health disorders.

### **Personal Support Specialist (PSS)**

is a certification issued by the State of Maine that enables you to help people with bathing and dressing assistance, transportation, grocery shopping or light housekeeping and laundry services. If you have your PSS certificate you can work with the elderly or the disabled and help in their everyday lives.
